



PROSECUTION UNIT APRIL 2024 REPORT

SUMMARY

 The Prosecution and Public Rights Unit of the Alameda City Attorney's Office represents the People of the State of California in misdemeanor criminal matters. The Unit is further charged with bringing affirmative litigation in response to violations of consumer protection and fair housing laws, and protecting consumers against fraud and unfair business practices. This report is to summarize the Prosecution and Public Rights Unit's activity for the month of April 2024.



CRIMINAL MATTERS

For the month of April 2024, the Alameda City Attorney's Prosecution and Public Rights Unit reviewed **81** requests for charges, **32** of which resulted in the filing of a criminal case, including the following crimes:


EXAMPLES OF NEW HOUSING CASES THIS MONTH

A consumer alleges that DeLauer's Newsstand is allowing her minor child to purchase cigarettes at their business. A landlord alleges she is attempting to make repairs in her unit, but her tenant is refusing to give her access despite her following the law on noticing procedures. She is requesting mediation so she can make the necessary repairs.

A landlord claims his tenants are harassing him and obstructing his ability to make repairs. He claims he needs to renovate and repair a faulty window, but his tenants are refusing to let in the repairmen, and when they, they harass them into leaving.



CIVIL MATTERS



EXAMPLES OF EXISTING CASE LOAD

A tenant alleges he is being forced out of his home by his property management company. The tenant alleges his property management company does not consider him a tenant, but rather, a squatter. He claims he has paid them rent, which they have accepted, for months and is unsure of why they now consider him a squatter.

A potential tenant alleges source of income discrimination. The potential tenant claims she was discriminated against by a local homeowner when he told her he no longer wanted to rent his property to her. She claims this occurred because of the section 8 inspection process, which she further claims the landlord was exasperated by, something he made clear to her. A tenant claims their property management company is harassing them, attempting to enter their unit without proper notice and failing to provide reasonable accommodation when requested.

A tenant alleges their property management company is harassing hem and is conspiring to evict them from their unit in retaliation for their many habitability complaints.
