

## **SUMMARY**

The Prosecution and Public Rights Unit of the Alameda City Attorney's Office represents the People of the State of California in misdemeanor criminal matters. The Unit is further charged with bringing affirmative litigation in response to violations of consumer protection and fair housing laws, and protecting consumers against fraud and unfair business practices. This report is to summarize the Prosecution and Public Rights Unit's activity for the month of July 2024.

For the month of July 2024, the Alameda City Attorney's Prosecution and Public Rights Unit reviewed **86** requests for charges, **52** of which resulted in the filing of a criminal case, including the following crimes:



### EXAMPLES OF NEW HOUSING CASES THIS MONTH


A case involving a tenant who claims after they moved out of their unit, they received a notice from collections for past due rent. The notice claims they lived at the unit for nearly a year after they had already vacated the property.

A case involving a tenant who claims they were illegally evicted from their unit by their landlord. The tenant further alleges the landlord entered their unit without notice, sent threatening texts and other harassing behaviors, while they were in the unit and has continued to do so now that they are gone.

One case involving a tenant who is concerned about their safety due to the managements refusal to address the homeless who have begun living and sleeping in and around their apartment building.



## **CIVIL MATTERS**



Two tenants claim when they moved out of their unit, they were told their inspection was good and they did not need to fix anything. However, after vacating, they received a notice from collections on behalf of the management company stating they owed money for vacating the unit without making repairs.

**EXAMPLES OF EXISTING CASE LOAD** 

A tenant alleges his landlord is knowingly allowing the gas meters at this multifamily property to remain incorrectly connected. Specifically, he states his meter and his neighbor's meter are switched, while a third tenant doesn't have a meter at all. He believes he and his neighbor are paying for this third tenant's gas, and alleges his landlord knows about this.

A housing applicant, who is a section 8 voucher holder, alleges she was discriminated against based on her source of income by a local property management company.

A tenant alleges harassment by her landlord. The tenant claims her landlord has placed cameras outside her windows and doorways which peer into her unit, she further claims he parks a loud vehicle right outside her window in the early hours of the weekend and works with machinery near her unit, creating a noise disturbance.
