

**CITY OF ALAMEDA
2024-25 BUSINESS LICENSE FEE SCHEDULE**

1. The Business categories listed below shall pay an annual business license fee of forty cents (\$.40) for each one thousand dollars of gross receipts, or gross payroll. The minimum fee schedule is as follows:

\$225.00 if total annual gross receipts are at least \$175,500.00 but not more than \$549,999.00.

\$176.00 if total annual gross receipts are at least \$88,000.00 but not more than \$175,499.00.

\$119.00 if total annual gross receipts are less than \$88,000.00.

| 10. Mechanical amusement device | \$60.00 per device |
| 11. Peddler & Solicitor | \$60.00/quarter per employee |
| 12. Public dance | \$25.00 per day or \$60.00 per quarter |
| 13. Taxicabs | \$40.00 per vehicle |
