BOCCE BALL COURT RENTAL

LOCATION: 1450 High Street (LINCOLN PARK)

DAYS: Monday, Wednesday, Thursday, Friday, Saturday, Sunday and Holidays: (No Tuesdays)

HOURS: 9:00 a.m. to half-hour after sunset.

RESERVATIONS:

- **All requests** to be made in person, by fax, or by emailing ARPD, during regular business hours at a **minimum of 7 days in advance** and a maximum of 6 months prior to your event. **Contact ARPD for availability** at above information.
- **Three-hour minimum** is required and permits are issued to adults 21 years and over.
- **Proof of residency is required** to obtain Alameda residency rates. This can be a utility bill.

PERMITS:

- Facility Use Permit is available online at: www.alamedaca.gov/recreation. Submit with payment and proof of residency if applicable. **No changes** allowed to permit after 7 days prior to event. Once received, we will issue you a permit number and mail it to you at the address you provide to us.
- **No on-going permits issued** for a regular week-to-week or month-to-month basis.
- **Reservation signs are posted and permits checked.** Your space is only guaranteed for the paid times listed on your permit.

ALCOHOL:

Alcohol is only permitted inside the fenced area of the Bocce Ball Court and not allowed outside in the Park. You must obtain an alcohol permit through www.cjprma.org and make sure the Recreation and Park Department has received your permit prior to bringing alcohol in the Bocce Ball Court. **This must be completed at least 2 weeks prior to your event.**

KEYS:

The Bocce Ball courts are locked and you will need to pick up the key for your reservation by 5:00 p.m. on Friday for a weekend reservation. If you are renting on a weekday, please pick up the key the day before by 5:00 p.m. At the end of your permit time, please be sure to lock the gate after using and not let anyone outside your party use this facility. All keys must be turned in to the ARPD Office mailbox at the end of your event.

FEES:

RESIDENT	NON-RESIDENTS
\$10 per hour with a 3-hour minimum	\$30 per hour with a 3-hour minimum

All fees must be paid in full at the time the reservation is issued. Cash, personal check (make payable to ARPD), Discover, VISA or MasterCard, cashier's check and money order are acceptable.

THE FOLLOWING ARE NOT ALLOWED IN THE CITY OF ALAMEDA PARKS:

- **NO Smoking** in parks or within 20 feet of entrance or windows of buildings. (Ordinance #3038).
- **NO Outside Barbeques.** There are charcoal barbecue grills available for use at the picnics sites. Please leave charcoal in the public BBQ and it will be disposed properly.
- **NO Amplified Music, P.A. Systems or Use of Air Horns.**
- **NO** nails, tacks, staples, electrical tape or other marring materials are to be used on any City property.
