### RESERVATIONS:

**All requests** to be made in person, by fax, or by emailing ARPD, during regular business hours at a **minimum of 7 days in advance** and a maximum of 6 month prior to your event.

**Contact ARPD for availability** at above information.

**Three-hour minimum** is required and permits are issued to adults 21 years and over. Set-up and clean-up time must be included in the total number of hours of the permit.

**Decorations must be removed at the end of the permit time.**

**Proof of residency is required.** This can be a utility bill.

**Holiday Weekend Rentals are available** on some holiday weekends with an additional 15% per hour charge. Please call for availability.

### PERMITS:

Facility Use Permit is available online at: [www.alamedaca.gov/recreation](http://www.alamedaca.gov/recreation). Submit with payment and proof of residency if applicable. **No changes** allowed to permit after 7 days prior to event. Once received, we will issue you a permit number and mail it to you at the address you provide to us.

**No on-going permits issued** for a regular week-to-week or month-to-month basis.

**Reservation signs are posted and permits checked.** Your space is only guaranteed for the paid times listed on your permit.

**Large special events require a Special Use Permit.** These include large organized events, such as a 5k Run, that impact a public right-of-way outside of the park. This may be obtained from the Community Development Dept., located at City Hall, 1<sup>st</sup> Floor. (510) 747- 6800. Please book your event with ARPD and the Special Use Permit is then required before the reservation is final.

**VENDORS:**

**The use of any outside vendors/contractors (clowns, inflatable jumpers, caterer, etc. by any rental groups must be approved by ARPD** prior to date of use, and may include additional fees. Additional insurance requirements must be met seven (7) working days prior to date of event.

**No personal inflatable devices are allowed.**

**FEES:**

**All fees must be paid in full at the time the reservation is issued.** Cash, personal check (payable to ARPD), VISA, MasterCard or Discover, cashier's check and money order are accepted. No partial payments accepted.

**Administration fee of \$15** is required for any changes to permit 7 days prior to event. No changes allowed after Tuesday night prior to reservation.

**Cancellations less than 7 days in advance forfeit all fees.** More than 7 days in advance require a \$15 administration fee.

**THE FOLLOWING ARE NOT ALLOWED IN ALAMEDA CITY PARKS:**

Nails, tacks, staples, electrical tape or marring materials are not to be used on any City property

**Alcoholic beverages**

**Amplified music, P.A. systems or use of air horns.**

**Outside barbecues.** There are charcoal barbecue grills available for use at the picnics sites. Please leave charcoal in the public BBQ and it will be disposed properly.

**Smoking is not allowed** in parks or within 20 feet of entrance or windows of buildings. (Ordinance #3038).
